Grand Prix: Following the conclusion of the Grand Prix, based on final scores (at least a 60%), the top 30 Athletes may go forward. This will be a maximum of 15 Athletes to the Freestyle, 15 Athletes to the Special for a total of 30 Athletes. Athletes (Riders) must give a 1st and 2nd choice in the order of the following two competitions they wish to enter (i.e. opt for the Grand Prix Freestyle as their 1st choice and the Grand Prix Special as their 2nd choice. if the Freestyle is over-subscribed; the Athlete (Rider) may start in the Grand Prix Special instead). Participation is, however, only possible in one (1) of the Competitions with the same Horse, and their original choice of Competition cannot be changed if there is space in that Competition.

Small Tour: Intermediate I: Limited to the top 30 riders qualifying from the Prix St Georges. Intermediate I Freestyle: Limited to the top 15 riders qualifying from the Intermediate I (60% or higher)

FEI Junior Rider / FEI Young Rider Tests: Limited to 2 per rider. Jr & YG Rider Freestyle: Limited to and compulsory to the top 15 riders qualifying from the Individual Test (60% or higher)

FEI Pony Rider / FEI Children Rider / Amateur Tests: limited to 1 per rider. Waivers can be granted if these classes fill enough to give the Athletes sufficient time between their rides. Additional entries accepted only on this condition. **FEI Pony Freestyle**: limited to and **compulsory** to the top 15 riders qualifying from the Pony Individual Test (60% or higher)

FEI Amateur Classes: Athletes from 26 years. Athletes must have no ranking with the FEI Dressage World Ranking List at the date of definite entry. Athletes living abroad may compete in Events of their host country, with permission from the NF of their host country. FEI Passport not required if competing in their home country. These horses must be registered with their NF, be identifiable by diagram, and have a valid vaccination certificate.

FEI U25 Classes: Open to riders 16-25 Intermediate II, YR Grand Prix 16-25, Grand Prix Freestyle 16-25. Grand Prix Freestyle 16-25: Limited to & compulsory to the top 15 riders from the YR Grand Prix 16-25 (60% or higher)

FEI Young Horse Classes: Limited to 1 per rider and must have a valid passport.

CDI Awards Information:

Prize Money and Tax Information: Prize money for competition will be will be paid directly by the facility accounting office to the designated payee within thirty (30) days of the end of the competition. U.S. Athletes must report winnings to IRS Form W9. Prize Money Won by Foreign Competitors: Be advised that the U.S. Internal Revenue Service requires sporting events to withhold 30% of prize money won in the United States. Foreign competitors should apply for a U.S. Social Security number and will be asked to complete form 8283 or complete a W-8 Certificate of Foreign Status form. National Class Information:

- Amateur Classes (AA) Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year in which they reach age 22.
 - Only active United States Equestrian Federation members may obtain amateur status. (Exception: Equine Canada members in possession of current EC membership may sign for USEF Amateur status on a show by show basis at no cost).
 - Participants must possess current USEF Amateur status and qualify under the USEF Amateur rules.
 If opportunity classes at Dressage Competitions are restricted to amateurs, riders are required to have an amateur status with USEF.

The Junior/Young Rider Classes (JR/YR)

Riders are eligible to compete in these classes until the end of the calendar year in which they reach the age of 21

The Pony division

For this competition, classes are offered from USEF Training Level through USEF Third level with classes designated for the JR/YR, the Adult Amateur, and the Open riders. The pony division is open to all breeds that meet the following measurement requirements. In the

Dressage Division, a pony is an animal that does not exceed 148 cm (14.23 hh) without shoes, and 149 cm (14.27 hh) with shoes. The

pony can be of any sex (Mare, Stallion, or Gelding).

- Ponies under the age of eight and in possession of a valid temporary card from another division or discipline should submit a copy with their entry.
- Measurement will be required for these pony specific classes if they do not currently have a valid measurement card. Measurement will be yearly beginning from the age of three (36 months) until the pony has reached the age of eight years. Animals three through seven years old will be issued an annual Temporary Certificate of Measurement and must be re measured annually until the age of eight years. Animals eight years and older will be issued Standard Certificates of Measurement which will not need to be renewed. Measurement must be done on USEF Combined Driving and Dressage

Pony Measurement form. Individual responsible for presenting the pony for measurement must be 18 years old. Animals submitted for measurement or re-measurement must show no evidence of lameness, and must be jogged for soundness prior to the measurement. Animals showing evidence of lameness are not eligible for measurement or re measurement.

- The pony must be entered to compete at the competition for a measurement to take place.
- When the competition veterinarian is on call and an alternative measurement time is necessary, management must receive a written request for measurement from the owner or agent at least five days prior to the start of competition to set up a time.

Opportunity Classes

Riders/Horses competing only in "opportunity" classes are exempt from membership requirements and do not have to pay NM, HID or USEF drug fees. In addition, owners, trainers & coaches are exempt from membership requirements for these classes. While membership requirements are waived for riders in "opportunity" classes all USEF Dressage Division rules apply (including dress & saddlery requirements) in addition to all applicable General Rules & Medications. "Opportunity" riders & horses may cross enter into non-opportunity classes, but if you do so all USEF/USDF membership requirements & fees will apply. Scores earned in "opportunity" classes may not be used toward USEF/USDF awards programs.

Classes per Day

Horses are limited to a maximum of three Dressage rides per day at Fourth Level and below (including Rider Tests) or two Dressage rides per day above Fourth Level. Horses competing at both Fourth Level and Prix St. Georges, or their equivalents, are limited to two Dressage rides per day. Dressage Seat Equitation, Quadrille, Pas de Deux and Materiale classes are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition.

Consecutive Levels

Horses may enter no more than two consecutive levels, Freestyle levels included, at any one competition.

Arena Size

All classes will be conducted in a standard size arena (20 m x 60 m)

Current Rules: The rules may have changed from the current USEF Rule Book. It is the competitor's responsibility to check the current USEF Rule Book for any changes. Current rules can be found on 60

Awards for National Classes: Ribbons to sixth place for each class. Divisions (JR/YR, AA, Open) may be run concurrently as one class. Divisions will be pinned separately. Riders must clearly specify division choice. When no designation is made, riders will automatically be entered as open. Riders may enter only one division per class.

Any additional prizes will be posted at the show office.

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of over 100 independent organizations throughout the United States with a membership of nearly 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

Entry Information:

Entry Information Requirements: Competitors are responsible to provide valid membership numbers on the entry form for all horse, owner, rider, and trainer names listed on the entry form. USEF and USDF registration is verified electronically if valid membership numbers are provided on the entry form. You may be asked to provide copies of your membership documents if your memberships cannot be verified for any reason. All hard copy entries must include copies of all memberships for horse, owner, rider and trainer listed on entry form. NO ENTRIES WILL BE ACCEPTED WITHOUT MEMBERSHIP CARD COPIES & COGGINS. No horse will be permitted on the grounds without a valid health certificate or proof of vaccinations (Equine Influenza Virus & Equine Herpes Virus (Rhinopneumonitis) with 6 months prior to arriving. Rule GR845

Entries must be received by Midnight of the closing date in the time zone of the competition. Any entry requiring a signature, payment, or copies of proof of valid membership will be considered incomplete and may incur additional fees. No refunds after closing date, for any reason.

- All fees must be paid in US funds. Fees must accompany the entry form for each show entered. Entries not accompanied by fees will be considered late and not entered until fees are received including any late or post entry fees.
- Entries postmarked or submitted after closing date will be considered late. Numbers will not be given out until entries have been submitted to the show AND owners, riders and coaches or trainers have signed all entry blanks.
- All entries for Open Classes are taken on a first come, first served basis. Only one horse-rider combination per entry form

Late Entries: Late entries will be accepted after the closing date if space is available, upon payment of an additional late entry fee.

Post Entries for: Entries will be accepted to fill scratches, up to the start of competition, if scheduling permits. No late entry fee will be required but will be required to pay a post entry fee in addition to the normal class fee.

Policy for Accepting Post Entries and Filling Scratches in classes: Must be eligible for class. Must have previously entered in

Membership/Registration Requirements for GAIG/USDF Qualifying Classes:

Horses with only an HID are not eligible. Owners must be current USDF Participating or Business members & USEF members (Junior, Senior or Life) in good standing. Great American/USDF Qualifying Classes: Please indicate that the class is to count for qualifying by placing a Q after the class number. An exhibitor riding in the Open, AA, JR/YR classes will pay an additional \$10 USDF fee to have this score entered in the Great American/USDF qualifying division at that level.

Show Schedule and Ride Time Conflicts: It is the responsibility of the rider to inform the management of any time conflicts as soon as possible after receiving the schedule. Organizers cannot guarantee that **CDI** draw times will not conflict with open class times.

Show Conflict/Rider Time Conflicts: Changes need to be requested in the show office by 3pm the day prior.

Cancellation prior to or on received by date - entire entry minus **office fee. No Refunds for any reason after closing date this includes weather, Acts of God, Accidents or Emergencies.** All fees collected on behalf of USEF/ USDF to be submitted to the Federation provided all outstanding show fees are paid in full; else it will be applied to those fees.

USEF Membership Statement (GR901.9)

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions; 8) Opportunity classes; 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation; 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

IMPORTANT EQUINE HEALTH INFORMATION

It is recommended that all horses stabling on the Colorado Horse Park grounds arrive between 7:00 am and 5:00 PM. If it is necessary to arrive at any other time you must make arrangements with the show office prior to arrival. (303) 841-7461.

Colorado Horse Park management strives to provide an excellent showing environment. An integral part of an excellent showing environment includes healthy horses. Exhibitors, especially those traveling long distances, can contribute to that healthy environment by following the following requirements for entry to the facility.

1) A current negative coggins test is required for all horses entering the facility. Please renew before it expires, and not just before it is necessary to leave the state.

2) Statement of Health / Veterinary Health Certificate signed by a licensed veterinarian within 7 days of first arrival at CHP, documenting that the horse has:

1. Received regular and consistent vaccination against Equine Influenza and EHV 1 & 4 with most recent booster being within 180 days. Written statements from Vet explaining reasons for being boostered within 180 Days MAY be accepted. IN NO CASES MAY THE BOOSTER BE OUTSIDE OF 180 DAYS. Horses not in compliance with this rule may be denied entry to the competition grounds upon request by Management.

Not shown symptoms of or been treated for EHV-4/1 within the past 28 days.
 Not been at a facility under quarantine for EHV-4/1 or exposed to any horses showing symptoms of EHV-4/1 within the past 28 days.

3) Current vaccination against WNV, EEE, WEE, Tetanus. Rabies is strongly recommended.

4) The Colorado Horse Park offers two ways for owners to provide required health documentation to gain access to the facility: Pre-Check Clearance (submission of documentation prior to arrival and providing biosecurity staff your horse's Pre-Check Clearance ID Number for quick and easy entry) and At-Gate (submission of all paperwork for inspection by biosecurity staff upon arrival to the facility). On select days, on-site vet inspections will be available for fee, for convenient Entry Health Pass to the facility (CHP Health Pass is valid for one entry only and would replace the requirement for a Veterinary Health Certificate). Details will be available as of April 1, 2017, at www.coloradohorsepark.com. Please monitor the Colorado Horse Park web site at for updates and/or health alerts, as entry protocol may change with the occurrence of any active illness cases in the State.

5) You should be able to document your horse's normal temperature before arrival. Please do not ship horses with elevated temperatures. It is recommended that you establish a log of temperatures taken at least twice daily. Any horse on the show grounds with a fever of unknown origin or of suspicious origin must be reported to Colorado Horse Park Management and the Official Veterinarian. It is always better to err on the side safety. Isolation stalls will either be available on the grounds or at a local veterinary practice if the need arises.

6) Every effort should be made to minimize stress and commingling of horses shipped long distances. Extra hours on a horse van, or moving from stable to stable is the fastest way to compromise your horse's and your neighbor's horse's health.

7) Please take the time to review equine good hygiene practices and impress its importance to your groom in everyday care.

US EQUESTRIAN FEDERATION rules are in force from the moment show management allows access to the showgrounds. This includes conduct, correct saddlery and equipment, and attire.

Liability – Horses by their inherent nature present a risk. This show, the management, the USEF Licensee, and the facility will not be responsible for any loss or damage or injury to horses exhibited, or for any article of any kind or nature that may be lost or destroyed, or in any way injured. Each exhibitor will be responsible for any injury that may be occasioned to any person, whomsoever, by any horse owned or exhibited by said exhibitor and shall indemnify the show, the management, the show committee and volunteers, the USEF Licensee, the USEF and USDF, or any member thereof, against all claims and demands, of any nature or kind, that may grow out of any injury occasioned by any horses owned or exhibited by them, or arise from the negligence of the person in charge of any such horse. All horses exhibited in this show participate entirely at the owner's risk. Neither the Organizing Committee, show volunteers and staff, the facility or its owners, USEF or USDF or their members will be responsible for any damage, injury, or loss to persons, horses, or property of exhibitors or spectators. All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date. A trainer is defined as any adult who has responsibility for the horse on the competition grounds and must sign the entry form.

Protective Headgear Rule: From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds including non-competing riders, riders on non-competing horses and those competing in all classes and tests must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must be immediately prohibited from further riding until such headgear is properly in place. Protective headgear is defined a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted.



<u>USDF Membership Benefits</u>: USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the USDF Member Guide or the USDF website at www.usdf.org.



Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or

owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.) Individuals cannot compete at a USEF-licensed/USDF-recognized competition with a USDF Education Membership.

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
 identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$75), 5-years (\$300), or life (\$1,500). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$60). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan[®]/USDF Year-End Awards, Great American Insurance Group/USDF Breeders Championship Series Finals and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$200) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Education Membership (EM): A membership issued to an individual directly by USDF. This online education only membership expires 12 months after the date joined. This membership type does NOT allow an individual to compete at a USEF-licensed/USDF-recognized competition.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$25 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$25). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequar[®]/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes or Great American Insurance Group/USDF Breeders Championship Series Finals. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$70. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$95) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete at Great American Insurance Group/USDF Breeders Championship Series Finals and Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.



2017 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at <u>www.usdf.org</u>. Please refer to the 2017 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

Rider:

- Must have a USDF Participating* Membership (PM) at the time qualifying scores are earned and at the time of the championships.
- Must have a USEF membership (Junior Active, Senior Active, or Life) at the time the qualifying scores are earned and at the time of the championships.

Horse:

- Must have a USDF Lifetime Horse Registration (LHR) at the time qualifying scores are earned and at the time of the championships.
- Must have a USEF (Annual or Lifetime) Membership recorded at the time qualifying scores are earned and at the time of the championships.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s) of record.
- A horse is not required to have breed registry papers.

Owner:

- Must have a USDF membership (PM* or Business Membership (BM)) at the time the qualifying scores are earned and at the time of the championships.
- Must have a USEF membership (Junior Active, Senior Active, or Life) at the time qualifying scores are earned and at the time
 of the championships.
- * PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division. Freestyles have only open divisions.
