### Alex Granato

Alex Granato is a professional show jumper originally from Salt Lake City, Utah who has represented the U.S. in Nations Cup competition and won over 40 Grand Prix events across the U.S. Alex and Mad Season, LLC are based out of Wellington, FL.

Alex's accolades include a top 25 of the Rolex USET Ranking List, multiple wins at Global Champions Tour 2\* Series in Miami, FL; and competing for the US in the CSIO 3\* in Lisbon, Portugal, where he jumped the first clear round for U.S. Alex and his Mad Season, LLC team were chosen to have a training partnership with George H. Morris, the legendary equestrian trainer. While training with George greatly benefits Alex's horses and personal equestrian pursuits, he also imparts his learnings onto his clients, of which range from beginning hunter and jumper riders to Grand Prix level. In his spare time, Alex runs The Peeps Foundation with Josh Dolan, his fellow Mad Season, LLC partner. The Peeps Foundation helps rescue, rehabilitate, and rehome miniature horses.

For Alex's Ride & Learn Sessions at The Colorado Horse Park he will help horse and rider combinations with the tools necessary to reach future goals. He will also discuss his recipe for success during an intimate reception after the first day of his clinics.
