

The Colorado Horse Park General RV Reservation Request Forms

Each RV must have a reservation form sent to the office and be prepaid either by credit card or check in order to secure an RV spot. Please note: all RV spots are first come, first serve. RVs that arrive without a reservation will not be able to park on the grounds.

Policies and Information

1. **Quiet Hours:** 10:00 PM to 7:00 AM. Please be courteous to help maintain a friendly atmosphere. RVs who violate the Quiet Hours will receive once (verbal or written) per length of stay. If a second warning is issued, the RV will be evicted without reimbursement.
2. **RV Site Assignment:** Each reservation will be assigned a site assignment pass that must be picked before entering the RV Campground. The pass must be prominently displayed at all time. RV locations will be assigned by The Colorado Horse Park.
3. **Dry Camping:** Dry camping may be allowed in within the RV Campground. Camping anywhere else is prohibited. Priority will be given to RVs with full hookups over dry camping. No tent camping is allowed.
4. **Alcohol, Illegal Drugs & Smoking:** All alcohol purchased for personal consumption must remain in the designated RV area. Personally purchased alcohol is not allowed on the show grounds. Illegal or sale of drugs is prohibited on the property at all times. All smoking must be done respectfully in designated areas.
5. **Vehicles:** All detached vehicles must be parked directly in front of their respective trailer. Only one licensed and registered vehicle per trailer allowed per site. All other vehicles must be properly parked in General Parking. Anyone operating a Motorized Vehicle **MUST** have a Valid Driver's License.
6. **Dogs:** RV Guests are responsible for their dog's conduct. Dogs must be contained to their respective campsite - either by fence or by leash. CHP reserves the right to make final decisions for any pet.
7. **Horse:** Horses are not allowed in RV Campground at anytime.
8. **Personal Conduct:** Any public disturbance will not be tolerated. All occupants and guests must comply with all federal, state & local laws, in addition to The Colorado Horse Park rules. Please keep sites clean and neat. All trash must be placed in dumpsters - not in RV Sites.
9. **Children Minors:** Any renter who has children of minor age is solely responsible for them and their actions.
10. **Liability:** The RV Park and its premises are intended for safe usage by its renters, family members, and/or guest(s). Any and all persons entering the RV Park are entering at their own risk and consent. The Colorado Horse Park is not responsible for any electrical spikes and/or accidents due to wind, flood, fire, theft, personal negligence or any other circumstances or acts of God. The person who rents the RV site space is individually and financially responsible for themselves, pets, RV, trailers, private vehicles, property and guest(s) while on the RV Park property. It is the responsibility of the person renting the space to inform all family members and guests of these rules.
